

Agreement

This Publishing Agreement (Agreement) between **Innovative Research Publications**, Bhopal MP India (Publisher), and the author whose name and signature appear at the bottom of this agreement. WHEREAS the Publisher and the Author wish respectively to publish and to have published the Author's work (book) listed at the bottom of this agreement.

1. **License of Rights:** The Author hereby grants to the Publisher to print, publish & sell in any form.
2. **Editorial Control:** The Author has to provide the content for ready to print otherwise the author have to pay the fee.
3. **Copyright Notice:** All distributed copies will bear a copyright notice in the name of the Author.
4. **Manuscript Submission:** The Author will submit all Required Materials relating to the Publishing book/magazine before processing.
5. **Fees:** The Publisher's fees for services will be charged according to mutual discussion and The Publisher may change fees, at any time, at its sole discretion.
6. **Pricing:** The pricing for the Book (ebook & print book) will be decided by the Publisher after consultation with the Author.
7. **Date of Publication:** The Publisher will publish the work 30 to 90 days after the Submission Date. In no event will the Publisher be responsible for delays caused by circumstances beyond its control.
8. **Style of Publication:** The Publisher will design the work's interior layout and cover in consultation with the Author. Final pricing will be at the sole discretion of the Publisher.
9. **Registrations for ISBN:** The Publisher will secure an ISBN for the printed & eBook.
10. **Distribution:** Initially publisher will publish book as eBook on major websites. Physically distribution of the book will be responsible of publisher and authors. The Publisher will retain the right to print and sell always.
11. **No Guarantee of Minimum Sales:** The Author acknowledges that the Publisher has no control over the purchasing decisions of book buyers and is not liable to any party if sales of the book do not meet the Author's expectations.
12. **Royalty:** Royalty sharing of physical and eBook selling shall be determined through consultation between the Publisher and the Author.
13. **Sample Copies for Author:** No. of sample copies will depend on the chosen package by the author.
14. **Author Discount:** The Author may purchase copies of the printed Work from the Publisher at 40% off plus shipping and handling charges.
15. **Publicity:** The Publisher reserves the right to publish information for publicity purposes. The Author will allow the Publisher to distribute promotional copies of the book free of charge, as deemed necessary by the Publisher. The Author will receive no royalties for such copies
16. **Permission for Copyrighted Material:** If the Author incorporates in the book any copyrighted material, the author will attempt to procure permission to use copyrighted materials in the Book. The cost of copyright permissions and their procurement will be paid by the author only.
17. **The Author represents and warrants to the Publisher:**
 - i. That he/she is the sole owner of the book and of all the rights granted to the Publisher.
 - ii. That he/she has not assigned, pledged, or otherwise encumbered the rights to the book.
 - iii. That he/she has full power to enter into this Agreement.
 - iv. That the book is entirely original except for portions thereof for which legally effective written licenses or permissions have been secured.
 - v. That the book does not violate or infringe upon any personal or proprietary rights including without limitation privacy rights, contract rights, or publicity rights of any other persons or entities.
 - vi. That the book is not libelous or obscene.
 - vii. That the Work does not infringe upon any statutory or common law copyright.

[Note : If any such claim, action, or proceeding is instituted, the Publisher will promptly notify the Author, who will fully cooperate in the defense thereof, and the Publisher may withhold payments of reasonable amounts due the Author under this or any other agreement between the parties.]
